**Between December 1, 2022 – January 31, 2023**

- \_\_\_\_\_ \$22.00 - Regular Tag
- \_\_\_\_\_ \$66.00 - 3 Year Tag (This tag is good for January 2023-December 2025 and is non-transferrable between dogs)\*
- \_\_\_\_\_ \$220.00 - Permanent Tag (This tag is good for the lifetime of dog it is purchased for and is non-transferrable between dogs)\*
- \_\_\_\_\_ \$100.00 - Kennel Renewal (New Kennels must be approved by the Clark County Dog Warden before they can purchase a Kennel License)

\* 3 year and Permanent Tags can only be purchased at the Auditor's Office.

**After January 31, 2023 and you have owned the dog for more than 30 days (\$22 penalty is included)**

**After January 31, 2023 and you have owned the dog 30 days or less or puppies who are 3 months old**

**On or After JULY 1, 2023 – Puppies born after April 1, 2023 or any Dogs brought in from another State.**

**(These tags can only be purchased at the Auditor's Office after July 1<sup>st</sup>)**

- A penalty shall be assessed if Dog License is not secured on or before January 31<sup>st</sup>, or within 30 days after the dog becomes 3 months of age, or is brought from outside the state. ORC Sec 955.01, 05
- Certificates of registration and registration tags shall be valid only during the CALENDAR year or years for which they are issued. ORC Sec 955.09

**All Dogs must have a current Dog License within 30 days of ownership or by the time it is 3 months of age**
